## Koop and BC-Envirotec join forces

**Frankfurt am Main, October 2023**. Koop Group GmbH a company in Borromin Capital Fund IV's portfolio, has announced the acquisition of 100% of the shares of BC-Envirotec GmbH (BC-E) from its managing shareholder Mario Tausch-Kienast as of 10<sup>th</sup> October 2023. The terms and conditions of the transaction have not been disclosed. With this, Koop continues its successful expansion strategy and development into the leading specialist for groundwater management and water purification solutions in Europe.

Since Borromin Capital Fund IV's original investment in Koop in August 2019, Koop has widened its branch network with two new branches in Germany (Berlin and Neustadt an der Weinstraße) and has successfully completed the acquisition of Buitenkamp and Clausen to further extend its geographical reach and service offering.

Marco Bernecker, managing partner of Borromin: "With the acquisition of BC-E, Koop's fast-growing water purification business will be expanded and in addition, strengthened by BC-E's highly experienced managing shareholder, who will continue to work for the Koop Group."

Ronny Konink, CEO of Koop Group: "We have seen a significant increase in demand for water purification in recent years, driven by increasing water quality regulations. The acquisition of BC-E offers Koop the possibility to establish a dedicated business unit, offering related services to accelerate further company growth."

the public sewer system in compliance with the relevant discharge criteria. The company is

groundwater management industry and also industrial customers and municipalities.
